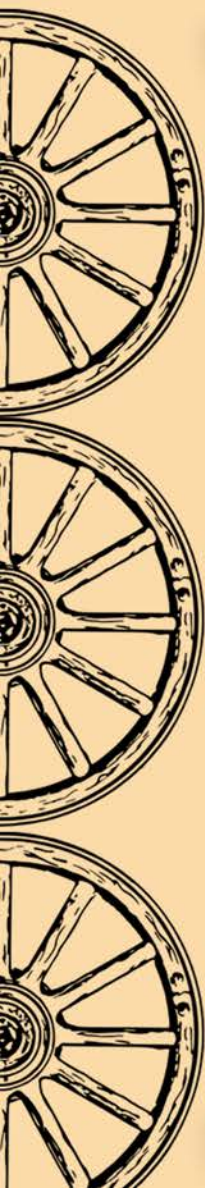

Horses shown in Class 5 cannot be shown in Class 2 and 3. Horses shown in Class 2 and 3 cannot be shown in Class 5.

Class 6 & 7

Three places to be paid in each division to qualified horses only. Fastest qualifying horse will be the first place in the first division. Each division to be separated by 1 sec.

We will not drag in these events. Horse cannot compete against itself in the same class. Riders may ride more than one horse. Poles and barrels are organized by the Overton Co. Horseman's Association.





RULES FOR ENTRANTS

1. Negative Coggins test is required.
2. Team Roper can only enter twice.
3. Competition open to all entrants.
4. Entry fee of \$10 per entry (per team) in classes 2, 3, 4, 5, 8, 9, 10. \$15 per entry in classes 6 & 7.
5. No entries will be accepted after 8:00 PM.
6. Entry fees will not be refunded for withdrawals of entrants in a class in progress.
7. Judges decisions are final in all classes.
8. Entrants names will be called only twice. A one-minute timer will begin after second call. If contestant has not entered the ring at the expiration of the timer, horse & rider will be disqualified.
9. Disqualified riders are not eligible for a refund of entry fees.
10. Adjustments cannot be made to any poles, barrels, or other course designations without judge approval.
11. Non-approved adjustments will be subject to time penalties or disqualification per the judge.
12. Horses may be entered in each class only once.
13. 2016 TSCA rules and guidelines will be followed when applicable, unless otherwise stated above.
14. Unauthorized persons will not be allowed inside the show ring during any part of the competition.
15. Bank of Putnam County, Livingston Veterinary Clinic, OCHA, or OCFB Association will not be responsible for any accidents, injuries, or theft. You will be competing at your own risk.
